
Re: Late Fee Assessment

LATE FEE ASSESSMENT ORDER

WHEREAS, Charles "Charlie" Schrumpf, in his capacity as a candidate for City Judge, City Court, City of Sulphur in the November 4, 2014 election was required to file campaign finance reports pursuant to La. R.S. 18:1484.


WHEREAS, La. R.S. 18:1505.1 provides that it is a violation of the Campaign Finance Disclosure Act to fail to timely file campaign finance reports.

WHEREAS, in accordance with La. R.S. 18:1495.4D, Charles "Charlie" Schrumpf was required to file a Supplemental Report by February 18, 2020. Charles "Charlie" Schrumpf filed the report on February 26, 2020 and was 8 days late.

WHEREAS, La. R.S. 18:1505.4A(2)(a)(ii) provides that an automatic late fee of \$60 per day (not to exceed \$2,000) be assessed against Charles "Charlie" Schrumpf for this late filing.

ACCORDINGLY, IT IS ORDERED that a late fee of \$480 is assessed against Charles "Charlie" Schrumpf for failure to timely file his campaign finance disclosure report.
