Dear Madam/Sir:

I recently received a letter dated May 11, 2020 (see attached) regarding a late fee assessment related to the filing of my 2019 Supplemental Campaign Finance Disclosure Report. Per the letter, I was ten (10) days late in filing said report and now owe \$600. Please allow me to explain myself as to how this error occurred.

On November 26, 2019 I timely filed my final election report (see attached). However, I was notified via letter dated January 14, 2020 (see attached) by the Ethics Board I was required to file a supplemental report. I immediately contacted the Board of Ethics via telephone and was guided as to how to complete the supplemental report. I completed said report and submitted it approximately mid-January of 2020.

However, when I submitted the supplemental report, I failed to place my email address on the submission page, therefore the final step did not allow the report to go through. Because of this error, my supplemental report reflected in the system as not submitted. I was notified of the failure to submit and immediately contacted the Ethics Board to attempt to remedy the situation. I was informed via telephone the system displayed my supplemental report as being completed but not submitted. I immediately placed my email on the supplemental report and re-submitted it on February 28, 2020 (see attached receipt).


I ran a conservative grassroots campaign with minimal funding and expenditures. My "staff" consisted of my family and friends who mostly volunteered their time. I ask that, because it was a clerical error on my part, and not an intentional or irresponsible act that I receive consideration for waiving the \$600 late fee assessment.

I further ask the board to please review my reporting records throughout this campaign and my previous 2015 campaign to demonstrate that all other reports were timely completed and submitted. I hope my prior filing history further reflects that, what caused my supplemental report to be deemed late, was merely a clerical error and not an attempt to shirk

campaign finance laws. Again, I humbly ask the board to consider the error; the context in which it occurred; and the promptness in which it was corrected; when determining whether to waive the late fee. Because your last report for the election held **October 12, 2019** shows a "deficit" (i.e. outstanding debts or loans) of **\$4,008.00** and a surplus of **\$0.22**, **you are required** to file a supplemental report of receipts and disbursements **electronically** using L.E.A.D.E.R.S. Supplemental reports are filed annually and must be complete through the preceding December 31st. Supplemental reports are filed until all debts and loans, including the candidate's personal loans, have been reported as paid or forgiven. Once debts, loans, and expenses for an election have been satisfied any remaining funds should be reported as contributions for a future election on a report marked as an "annual" report. Separate reports marked "supplemental" should be filed for each election in which there was a deficit. If you are reporting on more than one election, keep records and reports separate.

Information regarding electronic filing using the Louisiana Ethics Administration Disclosure & Electronic Reporting System (LEADERS) is available on our website at www.ethics.la.gov.

If this is your first time electronically filing, you must submit an Electronic Filing Affidavit and **obtain a password and ID** from this office. Affidavits can be printed from our website and must be received no later than **February 2, 2020**.

Late fees of \$60.00 per day for district office candidates will be assessed for every day supplemental reports are late.

If you have accepted a contribution for a future election, an annual report should be filed in addition to the supplemental report. Annual reports are also due by **February 18, 2020**.

Enclosed is an assessment of a late fee pursuant to La R.S. 18:1505.4 and La. R.S. 18:1511.4.1. Please submit a check or money order in the amount of **\$600** payable to the Treasurer of the State of Louisiana to P. O. Box 4368, Baton Rouge, LA 70821. **Please note that late fees can only be paid by the candidate or by his campaign.**

You have 20 days from receipt of this letter to dispute this assessment. You may elect to do either or both of the following:

1. You may submit your request for a waiver to the attention of the Louisiana Board of Ethics.

Waivers are handled by the Ethics Board. The Board of Ethics may reduce, suspend, or decline to waive a late fee assessment based on the cause shown by the person, candidate, or political committee. If you submit a request for a waiver of the late fee to the Board of Ethics, your request should contain details as to why, in your opinion, you have good cause why your report was not timely filed. Also, if you would like to appear before the Board of Ethics in connection with your request, you should state that in your letter. The request should be submitted to the attention of the Board of Ethics at the following address: P. O. Box 4368, Baton Rouge, LA 70821 or fax at (225) 381-7271.

2. You may appeal the assessment directly to the Ethics Adjudicatory Board (EAB).

Appeals to the EAB are proceedings before a three judge panel. The determination is made regarding whether the person, candidate, or political committee was required to file the report and whether the report was filed late. **Mitigating factors are not considered during an EAB proceeding. The EAB does not have the authority to reduce, suspend, or waive a late fee assessment.** If you choose to appeal the assessment to the EAB, you should submit your request for an appeal to the attention of the Executive Secretary of the Louisiana Board of Ethics at P. O. Box 4368, Baton Rouge, LA 70821 or fax at (225)381-7271.

If you timely submit a waiver request or appeal, your name will not be posted on the website pending the result of your appeal. Furthermore, if you request an appearance, you will be notified of the place and time prior to the meeting.

If you do not **pay or dispute** the assessment of the late fee within 20 days from the receipt of this letter, the matter will be forwarded to the Attorney General's Office to pursue collection. If the matter is forwarded to the Attorney General's Office for collection, you may be responsible for all additional costs incurred. Additionally, late fees not paid by the due date will be posted on the agency website.

You should be aware that unpaid campaign finance fines, fees or penalties may have an adverse effect on your ability to run for public office in the future, as the Board of Ethics will object to your future qualifications for candidacy for public office pursuant to La. R.S. 18:491 and R.S. 18:492.

WHEREAS, Joseph "Joe" Fertitta, in his capacity as a candidate for Parish President in the October 12, 2019 election was required to file campaign finance reports pursuant to La. R.S. 18:1484.


WHEREAS, La. R.S. 18:1505.1 provides that it is a violation of the Campaign Finance Disclosure Act to fail to timely file campaign finance reports.

WHEREAS, in accordance with La. R.S. 18:1495.4D, Joseph "Joe" Fertitta was required to file a Supplemental Report by February 18, 2020. Joseph "Joe" Fertitta filed the report on February 28, 2020 and was 10 days late.

WHEREAS, La. R.S. 18:1505.4A(2)(a)(ii) provides that an automatic late fee of \$60 per day (not to exceed \$2,000) be assessed against Joseph "Joe" Fertitta for this late filing.

ACCORDINGLY, IT IS ORDERED that a late fee of \$600 is assessed against Joseph "Joe" Fertitta for failure to timely file his campaign finance disclosure report.
