

LATE FEE ASSESSMENT ORDER

WHEREAS, John L. "Jay" Dardenne, Jr., in his capacity as a candidate for Governor in the October 24, 2015 election was required to file campaign finance reports pursuant to La. R.S. 18:1484,


WHEREAS, La. R.S. 18:1505.1 provides that it is a violation of the Campaign Finance Disclosure Act to fail to timely file campaign finance reports.

WHEREAS, in accordance with La. R.S. 18:1495.4D, John L. "Jay" Dardenne, Jr. was required to file a Supplemental Report by February 18, 2020. John L. "Jay" Dardenne, Jr. filed the report on February 24, 2020 and was 6 days late.

WHEREAS, La. R.S. 18:1505.4A(2)(a)(i) provides that an automatic late fee of \$100 per day (not to exceed \$2,500) be assessed against John L. "Jay" Dardenne, Jr. for this late filing.

ACCORDINGLY, IT IS ORDERED that a late fee of \$600 is assessed against John L. "Jay" Dardenne, Jr. for failure to timely file his campaign finance disclosure report.
