COMMENTS:

Sheral Keller is requesting a waiver for failing to amend your 2017 disclosure timely. She stated she inadvertently filed the Tier 2 Disclosure instead of a Tier 2.1 Disclosure. In January 2016, she was appointed to the position of Assistant Secretary, Office of Workers' Compensation Administration (OWCA). By statute, the Assistant Secretary of OWCA is a member of the Second Injury Board (SIB). She attempted to comply with the provisions of L.S.A.-R.S. 42:1124.2.1 when she filed the Tier 2 form in June 2018 and thought this was the correct form. Ms. Kellar did not realize that it was incorrect until she received a certified notice instructing her to file a Tier 2.1 disclosure. On November 13, 2019, she received an e-mail from PFD Director stating that the BOE had not yet received the appropriate form and that several attempts had been made to contact her regarding her 2017 Amendment. On December 18, 2019, Kellar asked the PFD Director for a website hyperlink to the correct financial disclosure, which she received the same day. On January 17, 2020, she submitted a complaint 2017 Tier 2.1 PFD. Ms. Kellar apologizes for any inconvenience caused by her failure to timely file her amendment. She stated she neither knowingly, nor willfully failed to file the disclosure; she mistakenly completed and submitted the wrong Tier. Ms. Kellar stated she will unlikely make this error again and for that reason, asks the Ethics Board to waive her late fee. She thanks the Ethics Board in advance for the waiver consideration. This is Ms. Kellar's first late fee assessment.

Dear Board Members:

On July 14, 2020, I received a certified letter from the Louisiana Board of Ethics. The letter advised that I was being assessed a late fee of \$1,500, pursuant to L.S.A.-R.S. 43:1124.4, because I failed to timely file a 2017 Tier 2.1 Personal Financial Disclosure (PFD) form.

I hereby request a waiver of the fee. I neither willfully nor knowingly failed to file the required form. Instead, I inadvertently filed the Tier 2 form. In January 2016, I was appointed to the position of Assistant Secretary, Office of Workers' Compensation Administration (OWCA). By statute, the Assistant Secretary of OWCA is a member of the Second Injury Board (SIB). I attempted to comply with the provisions of L.S.A.-R.S. 42:1124.2.1 when I filed the Tier 2 form in June 2016. Erroneously, I thought this was the correct form. I did not realize that it was not the correct form until I received a certified letter from the Board on August 10, 2019 advising that I should file the Tier 2.1 PFD form, instead.

On November 13, 2019, I received an e-mail from Ashley Wimberley that reminded me that I had not filed the appropriate form. In that email, Ms. Wimberley advised me that the Louisiana Board of Ethics had been trying to contact me regarding my annual PFD for the SIB. I responded to Ms. Wimberley's e-mail on December 18, 2019, asking her to send me a hyperlink to the financial disclosure form that I should have filed. Ms. Wimberley sent me the requested information on the same date. On January 17, 2020, I filed the Tier 2.1 PFD statement for 2017.

I apologize for any inconvenience caused by my failure to timely file the 2017 PFD form. To reiterate, I neither knowingly nor willfully failed to timely file the required form. It was simply an oversight on my part. I am not likely to make this mistake again during my continued tenure as Assistant Secretary. For the aforementioned reasons, I request a waiver of the late fee.

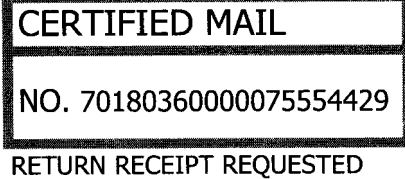
