

Dear Ms. Angela Newsom:

I was late one time in filing the annual report in February 2016 and paid about \$500 for the lateness. From then on, I always filed an annual report by the February deadlines every year. I didn't file an annual report in February 2020 because Ms. Sherry and I filed a final, closing report in February 2019.

You see, back in February 2019, with Ms. Sherry on the phone, we closed out my account with forgiving my debts to the campaign. Therefore, I didn't file the annual filing in February 2020. Then a new person helped me closed out the account with some technical filing assistance from her. I think her name is Sarah. This lady did tell me to expect some mail from your office about late fees within 10 days of March 2020. I have not received any notice about late filing fees and penalties for the period from February 15, 2020 until now, so I assumed that the fees were waived by your office and I have no fines pending. I did not receive anything from your office until today, about 2 weeks after I qualified to run for judge again.


Your letter, specifically the one herein marked as Exhibit A, page 1 of 5, is quite confusing. It seems to say that since I was late in filing the annual report in February 2020, I now must pay \$2000 as mandated by the Order dated September 21, 2016, herein marked as Exhibit A, pages 3-4. However, said order says I must pay \$2000 extra if I didn't pay the \$500 by October 24, 2016, which I paid. The order does not allow you to fine me \$2000 for late filing of the annual report in February 2020. Therefore, the fees assessed in Exhibit A herein must be dismissed as wrongly applied or assessed.

I am enclosing your 3 letters herein marked as Exhibit A, Exhibit B, and Exhibit C.

Please allow this letter to serve as my request for waiver and my dispute of the assessment by you. Fees assessed in Exhibit B and Exhibit C should be waived because your technical people assisted me and assured that me that my account was closed back in February 2019. And again in February 2020, I was assured that no late fees were assessed against me if no notice was sent out to me with 10 days of February 26, 2020 when the account was finally closed properly.

Again, I ask that you review your records and see that I should not be assessed these fees as I was not aware of being charged for late filing fees since your office didn't send me a notice after your technical person assisted me to properly close out the account on or around February/March 2020. I only received the attached in the mail a few days ago, on Friday, August 14, 2020.

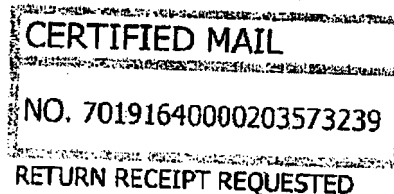

At its September 2016 meeting, the *Board of Ethics*, in its capacity as the Supervisory Committee on Campaign Finance Disclosure, (by majority vote) suspended a portion of the original late fee based on payment being made by October 24, 2016 and compliance with the Campaign Finance Disclosure Act in the future. Please submit a check or money order in the amount of \$500 payable to *Louisiana State Treasurer*, P. O. Box 4368, Baton Rouge, Louisiana 70821 by October 24, 2016. Please note that late fees can only be paid by the candidate or by his campaign.

You have 30 days from the mailing of this notice to submit payment or dispute the assessment. To dispute this assessment, you may elect to do either or both of the following:

1. You may request reconsideration of the reduced amount to the *Board of Ethics*. If you choose to request reconsideration, your request should include additional information not previously provided. If you would like to appear before the *Board of Ethics* in connection with your request, you should state that in your letter. If you request an appearance, you will be notified of the place and time prior to the meeting. The request should be submitted to: *Louisiana Board of Ethics* Post Office Box 4368, Baton Rouge, Louisiana, 70821. You may also fax the request to 225/381-7271. If the *Board of Ethics* denies your request, you may appeal the reduced amount to the *Ethics Adjudicatory Board*.
2. You may request an appeal of the assessment to the *Ethics Adjudicatory Board*. If you choose to request an appeal, your request should be submitted to: *Louisiana Board of Ethics* Post Office Box 4368, Baton Rouge, Louisiana 70821. You may also fax the request to 225/381-7271.

If you do not pay or dispute the reduced amount of \$500 by October 24, 2016, then the original late fee becomes immediately due and owing. If you do not pay or dispute the assessment of the late fee within 20 days from the receipt of this letter, the matter will be forwarded to the Attorney General's Office to pursue collection. If the matter is forwarded to the Attorney General's Office for collection, you may be responsible for all additional costs incurred. Additionally, late fees not paid by the due date will be posted on the agency website.

You should be aware that unpaid campaign finance fines, fees or penalties may have an adverse effect on your ability to run for public office in the future, as the Board of Ethics will object to your future qualifications for candidacy for public office pursuant to La. R.S. 18:491 and R.S. 18:492.


WHEREAS, La. R.S. 18:1505.1 provides that it is a violation of the Campaign Finance Disclosure Act to fail to timely file campaign finance reports,

WHEREAS, in accordance with La. R.S. 18:1495.4D, Trina Trinhthi Chu was required to file a Supplemental Report by February 18, 2020. Trina Trinhthi Chu filed the report on February 26, 2020 and was 8 days late.

WHEREAS, La. R.S. 18:1505.4A(2)(a)(i) provides that an automatic late fee of \$100 per day (not to exceed \$2,500) be assessed against Trina Trinhthi Chu, her committee's chairperson, Vandana Chaturvedi and treasurer, Reshma Paralikar for this late filing.

ACCORDINGLY, IT IS ORDERED that a late fee of \$800 is assessed against Trina Trinhthi Chu, her committee's chairperson, Vandana Chaturvedi and treasurer, Reshma Paralikar for failure to timely file a 2019 Supplemental campaign finance disclosure report.
