The enclosed letter is to request a waiver of the Late Fee Assessment for the November 3, 2020 Election.



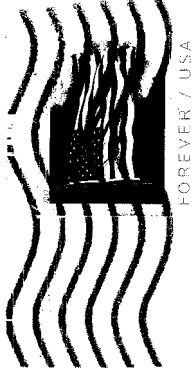

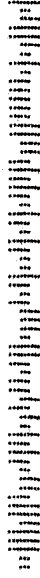
