CHARGES

The Louisiana Board of Ethics voted on February 6, 2020, to and does hereby file the following charges:

1.

On April 3, 2018, Ricky Richard was hired by the Town of Grand Coteau as a Utility Worker for the Utility Department.

2.

On November 6, 2018, James Wayne Richard was elected as Alderman of the Town of Grand Coteau and commissioned on January 1, 2019.

3.

On December 8, 2018, Patrick Richard was elected as Mayor of the Town of Grand Coteau and commissioned on January 1, 2019.

4.

James Wayne Richard, Patrick Richard and Ricky Richard are brothers, making Ricky Richard an immediate family member of James Wayne Richard and Patrick Richard as defined by La. R.S. 42:1102(13) of the Louisiana Code of Governmental Ethics.

5.

La. R.S. 42:1119A provides:

No member of the immediate family of an agency head shall be employed in his agency.

6.

La. R.S. 42:1119C(2) provides:

The provisions of this Section shall not prohibit the continued employment of any public employee nor shall it be construed to hinder, alter, or in any way affect normal promotional advancements for such public employee where a member of public employees' immediate family becomes the agency head of such public employee's agency, provided that such public employee has been employed in the agency for a period of at least one year prior to the member of the public employee's immediate family becoming the agency head.

7.

La. R.S. 42:1102(13) provides:

"Immediate family" as the term relates to a public servant means his children, the spouses of his children, his brothers and their spouses, his sisters and their spouses, his parents, his spouse, and the parents of his spouse.

8.

La. R.S. 42:1102(3) provides:

"Agency head" means the chief executive or administrative officer of an agency or any member of a board or commission who exercises supervision over the agency.

9.

La. R.S. 42:1102(2)(a)(vi) provides:

"Agency" means a department, office, division, agency, commission, board, committee, or other organizational unit of a governmental entity. For purposes of

this Chapter, “agency of the public servant” and “his agency” when used in reference to the agency of a public servant shall mean:

(vi) For public servants of political subdivision, it shall mean the agency in which the public servant serves, except that for members of any governing authority and for the elected or appointed chief executive of a governmental entity, it shall mean the governmental entity.



Based on the foregoing facts, Ricky Richard, while employed by the Town of Grand Coteau as a Utility Worker, violated La. R.S. 42:1119A by remaining employed after his brothers, James Wayne Richard and Patrick Richard, were commissioned as Alderman and Mayor of the Town of Grand Coteau, respectively, given that Ricky Richard had not been employed by the Town of Grand Coteau for a period of at least one year prior to James Wayne Richard and Patrick Richard becoming the agency heads when they were commissioned as Alderman and Mayor on January 1, 2019.

In accordance with La. R.S. 42:1141C(3)(b)(iv), the Board designates Gregory L. Thibodeaux and Tracy Barker as the Board’s trial attorneys in this matter.

WHEREFORE, the Louisiana Board of Ethics requests that the Ethics Adjudicatory Board (a) conduct a hearing on the foregoing charge; (b) determine that Ricky Richard violated La. R.S. 42:1119A; and (c) assess appropriate penalties in accordance with the recommendation of the Louisiana Board of Ethics to be submitted at the hearing.
