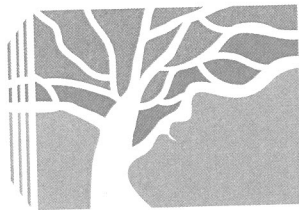

Is this a conflict of interest to have Peyton Falgoust on our Library Board of Control?

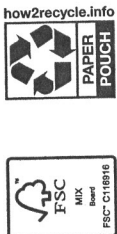

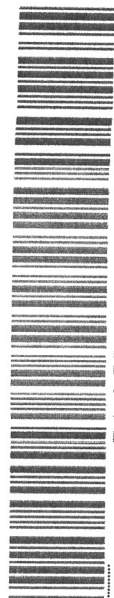

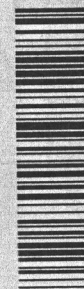
