Mr. Tucker:

On December 11, 2020, a hearing was conducted wherein the Ethics Adjudicatory Board (the "EAB") determined that your 10-P campaign finance disclosure report in connection with the October 12, 2019 election is more than 6 days late, and ordered that the Louisiana Board of Ethics (the "Board") is authorized to impose upon you additional civil penalties as allowed by La. R.S. 18:1505.4(A)(4)(a). Further, the EAB determined that your 10-G campaign finance disclosure report in connection with the October 12, 2019 election is more than 11 days late, and ordered that the Board is authorized to impose upon you additional civil penalties as allowed by La. R.S. 18:1505.4(A)(4)(b).

La. R.S. 18:1505.4(A)(4)(a) and La. R.S. 18:1505.4(A)(4)(b) provide that if, after conducting an adjudicatory hearing, the EAB determines that a candidate failed to file the required campaign finance disclosure reports more than 6 or 11 days late, respectively, the Board, functioning as the Supervisory Committee under the Campaign Finance Disclosure Act, may impose upon the candidate additional penalties not to exceed \$10,000 per report.

This letter is to give you notice that this matter will be considered by the Board at its August 6, 2021 meeting for the assessment of an additional \$10,000 for each report pursuant to La. R.S. 18:1505.4(A)(4)(b). The meeting will be held at 9:00 a.m. on August 6, 2021 in the LaSalle Building, LaBelle Room, 617 North Third Street, First Floor, Baton Rouge, Louisiana.
