On January 21, 2021, a hearing was conducted where ("EAB") determined that your 2019 supplemental campaign with the October 24, 2015 election is more than 11 day authorized to impose upon you additional civil fine 18:1505.4(A)(4)(b).

La. R.S. 18:1505.4(A)(4)(b) provides that if, after a hearing, the EAB determines that a candidate failed to file the required campaign report as the Superintendent of the campaign, the candidate shall be fined not more than \$500.
